- 1. **C** Only the current DEM can issue new or renew warrants
- 2. **NO** In Atlantia there is no requirement to renew your warrant each year. A marshal's warrant is good for 3 years provided they are a current SCA member and their marshal's class is current.
- 3. **D** Both B&C are correct. We as marshals should always try to assure we make archers aware of unsafe conditions and making the MIC aware is the correct thing to do.
- 4. **YES** This is correct. Only the DEM can grant a waiver for a handicapped archer on a recurring basis. MIC's of individual events may grant a waiver for a handicapped archer for that event only. **(SCA Archery Rules, Equipment Standards/General Standards #4B/C)**
- 5. **F** None of the above as already mentioned, we do not need to renew our warrants each year.
- 6. **B** This is a tough call and the correct answer really depends. A marshal will never fully know how bad the damage is on a bow. If the crack does not penetrate into the wood and it is only in the clear coat the bow is most likely alright to shoot. If it is a fiberglass bow and the crack does run with the grain it might be alright as well. I would stress to archers to NOT shoot damaged hows
- 7. **C** as per our range safety rules, this is the correct answer. **(SCA Archery Rules, Additional Recommendations, Suggested Range Dimensions, Target Shoots #1)**
- 8. **A** The parents need to be present at the range with their minor at all times. This is based on recent changes directed by the Kingdom Seneschal about minors. Anyone under the age of 18 is now considered a minor.
- 9. **YES** There should be as little obstructions and adequate distance for the safety zones around the range.
- 10. **C** Any arrows prior to the "L" and after the "D" should be considered as non scoring as they were outside the period of shooting allowed. **(Atlantia Archery Rules, Section 3.9.4.3)**
- 11. **D** Make sure the range is clear and call the archers to the line.
- 12. **D** As per Kingdom rules only the Autocrat can cancel an activity at an event. So if there is a pressing safety issue, the MIC or other marshals need to work with the Autocrat and no one else to rectify the problems or cancel the activity.
- 13. **B** Regional marshals are in place to cover events that the DEM or EDEM might not be attending. They can act in the place of the DEM if required and authorized to do so.
- 14. **F** This is the correct answer; we have no rule for draw weight limitations in Atlantia.
- 15. **C** Archers need to straddle the line while shooting.
- 16. **B** The advantage goes to the archer when scoring.
- 17. **D** Anyone can call hold if they feel there is a safety issue.
- 18. **C** Only the MIC can clear the hold once it has been called.
- 19. **INCORRECT** Even though we have an inspection requirement by our marshals, each archer is responsible for their own equipment and should inspect it every time prior to shooting or being inspected. **(SCA Archery Rules, Equipment Standards/General Standards #3)**
- 20. **CORRECT** Archers should wait to be called to the line by the marshal.

- 21. **INCORRECT** Archers should straddle the line when shooting. **(Atlantia Target Archery rules, section 3.9.4.1)**
- 22. **CORRECT** Archers are NOT to nock an arrow until directed by the line marshal.
- 23. **INCORRECT** When a hold is called, all archers are to un-nock their ammunition and step back from the line.
- 24. **CORRECT** When archers are done shooting, step back from the line so the marshal can clearly see you are done.
- 25. **CORRECT** Even if you drop an arrow across the line, do not bend down to pick them up or ever cross the shooting line until directed by the marshal.
- 26. **INCORRECT** Archers need to be cognizant of all "dead wood" laying around targets when attempting to pull their arrows from a target.
